## A Strategic Plan for a Changing Landscape

EKO is primed for growth and change. Our strategic planning process built upon previous successes, and focused on the trends likely to shape the child development and rehabilitation sector in coming years to determine how EKO could best respond.

Our vision remains unchanged: Kids with disabilities and their families living their best lives. It's a simple and powerful premise.

How do we make this happen?



EKO's Strategic Plan 2021-24 is our guide, designed to help build capacity in our rapidly changing world, to support kids with disabilities and their families in the coming years.



EKO will help its members, governments and other stakeholders better understand the experiences and priorities of kids with disabilities and their families so that they can better serve and support them.



EKO will help government better understand the value of responsive and innovative services and the policy and resourcing challenges faced in serving kids with disabilities and their families.



EKO will become an even more responsive, effective and properly-resourced organization in order to better engage and support a growing number of current and future members.



EKO will help a growing number of current and future members strengthen their capacity to respond to families, government policies, and changes in their overall operating environment.

## **COVID-19 Response and Recovery**

The global pandemic has been hard on Canadians, but it has affected kids with disabilities and their families disproportionately, pausing or limiting necessary supports, generating protocols that were unfriendly to kids with disabilities or even leaving kids with disabilities and their families without assistance. Many parents spoke of watching their kids lose hard-earned advances that were months or years in the making.<sup>1</sup>

EKO continued its work this year, supporting our sector's resiliency, providing leadership and tools to meet challenges, activating our network and partnerships, and always advocating for the needs of kids with disabilities and their families.

An essential element of the post-pandemic response for kids with disabilities is the in-person delivery of the School-based Rehabilitation Program. EKO worked with stakeholders to generate a shared understanding of the program's purpose and mandate. Gaining support for the Ministry of Children, Community and Social Services-funded program and its objectives ensures organizations responsible for the program have agreement from publicly funded Boards of Education, and Education Directors, to access to schools and classrooms, and engage with educators to the benefit of kids and families.

#### **Children's Health Coalition Ontario**

The Children's Health Coalition Ontario maintained an active voice as the province addressed the pandemic's challenges. The Coalition's advocacy has been successful in several ways:

- Pediatric expertise joined the provincial vaccine table with EKO represented at Ontario's Pediatric Vaccine Table
- Caregivers for kids with disabilities and kids with mental health needs included in the second wave of the vaccination rollout
- Ministry of Education recognition that in-person learning is essential for kids with complex care needs
- Messaging that schools must be the last to close and the first to re-open in the province's recovery plan shared by important influencers
- EKO joined Ontario's COVID Children's
  Response and Recovery Table, the single
  voice for children as the province navigates
  the fourth wave of the pandemic and
  concurrently addresses response and
  recovery.

#### **Vaccine Education Course**

The Ministry of Children, Community and Social Services directive issued in August required EKO members to adhere to a vaccination policy no later than September 23, 2021. To assist our members, EKO contracted the Ontario Public Health Association to design an education program satisfying these requirements and addressing issues specific to the demographics represented by EKO members' staff.

## **EKO's 2020 Fall Policy Forum**

The COVID-19 pandemic has made clear that complex problems are best addressed collaboratively, grounded in the experiences of the people who are closest to the issues. This year EKO activated a crowd-sourced approach to identify the policy issues that matter most to kids with disabilities and their families who navigate the system. Families and "graduates" shared their views about strategies to transform our system of care. This approach ensures EKO's input on policy discussions is family and client-focused, aligned with families' expectations, and grounded in health and social care system engagement standards that lead to improved outcomes.

## **Ontario's Historic Investment**

In the 2021 budget, Ontario's Action Plan: Protecting People's Health and Our Economy, the government included an historic investment in the child development and rehabilitation sector: \$240 million over four years to address wait lists for pediatric rehabilitation and child development. This will allow EKO members to see more of the kids who are waiting for all levels of service—whether they need only a few visits or many to help them achieve their goals. EKO is grateful for this funding that positions more kids to live their best lives, and for ongoing efforts to address the urgent treatment needs of kids with disabilities and their families.

## **Building Sector Capacity**

EKO secured grant funding from the Ministry of Children, Community and Social Services for a second phase of the Building Capacity program.

The program now includes a research component looking at virtual care. This work aims to determine the effectiveness of a broad range of virtual care services provided to Ontario children, focusing on the processes and outcomes of a variety of services to identify potential ways to enhance both program and service delivery, as well as measurement of the resulting impact of these services.

#### 2021 EKO Scholars

At EKO we believe nothing should stand in the way of promising young people pursuing their higher education and career goals, and we are honoured to recognize students with disabilities who have shown determination, self-advocacy, academic success and a commitment to their community, as they embark on this next phase of their lives.

This year EKO introduced a scholarship for Canadian First Nations, Métis and Inuit youth—a timely initiative given the association's further reach into Northern Ontario and growing relationships with organizations that serve Indigenous communities.

EKO Scholars are selected through a competitive process by a jury of leaders in healthcare, education, child development services, former EKO scholars, and those with lived experience of disability. The 2021 EKO Scholars are honour roll students, athletes—including a Paralympian in training with his goal set on the 2024 Paris games, a recipient of a Governor General's Caring Canadian award, advocates, actors, public speakers, mentors, and an aspiring novelist. All are attending Ontario college and university programs studying game development, arts and science, business law, health sciences, developmental services, and recreation therapy.














#### **EKO Tribute Awards**
